

### **PAYMENT TERMS & CONDITIONS**

## (For ZAR Rand Paying Students)

- 1. Accredited as both an RTO and Australian higher education provider, the Engineering Institute of Technology delivers industry focused microcredentials, vocational courses and higher education degrees to students from over 140 countries.
- 2. Students must successfully enrol and meet payment terms to progress a course with the Engineering Institute of Technology.
- 3. Applicants will receive an initial invoice upon finalisation of enrolment.
- 4. Once enrolled, for applicable courses, students will continue to receive monthly statements thereafter, which advise/remind of fees owing. Please note the amount shown on the statement is the total cost of the course/units enrolled in less any payments made to date. When considering whether tuition fees are tax deductible, we urge applicants/students to seek professional advice.

- 6. Payment may be made via Visa, MasterCard or by bank transfer into the Engineering Institute of Technology (Pty) Ltd bank account, the details of which will be provided on request.
  - Online payment through the DPO Gateway is only available to clients paying in South African RAND (ZAR).
- 7. Card transactions will be acquired for Engineering Institute of Technology via PayGate (Pty) Ltd who are the approved payment gateway for all South African Acquiring Banks. DPO PayGate uses the strictest form of encryption, namely Secure Socket Layer 3 (SSL3) and no Card details are stored on the website. Users may go to www.paygate.co.za to view their security certificate and security policy.
- 8. Customer details will be stored by Engineering Institute of Technology separately from card details which are entered by the client on DPO PayGate's secure site. For more detail on DPO PayGate refer to www.paygate.co.za.
- 9. The merchant outlet country at the time of presenting payment options to the cardholder is South Africa. Transaction currency is South African Rand (ZAR).
- 10. In the event of default of payment when due, all costs of collection, including legal fees and court costs, shall be paid by the student.
- 11. The Engineering Institute of Technology (EIT) acknowledges and respects your privacy. When you contact us or purchase any of our products or services we create a record with your contact



information. We may then add information that we collect, including information that you may give us during registration, to that record.

We will treat this information with the highest standards of confidentiality and privacy. Personal information will only be used for the purposes for which you have disclosed it to us. We may collect the following information:

- other information relevant to customer surveys and/or offers.
